

INCOMPLETELY FILLED IN ASSET DECLARATIONS OF PUBLIC OFFICIALS IN AMBROLAURI AND ONI

Transparency International Georgia reviewed the asset declarations of 39 public officials from the City Hall and Sakrebulo of the Municipalities of Ambrolauri and Oni, out of which 14 were filled in with violations. The research has found that four public officials have not transferred the management rights of their shares to a third party, and that four public officials are engaged in activities incompatible with office.

It is noteworthy that according to Article 18(1) of the Law on Conflict of Interest and Corruption in Public Service, an official is not obliged to disclose his or her entrepreneurial activity or the entrepreneurial activity of his or her family member in a company that has not had turnover for six or more years before the filing date of an asset declaration. Due to this, the Civil Service Bureau will not find the nondisclosure of such a company as a violation. It should be noted that Transparency International Georgia does not have the capacity to verify the turnover of a company. Therefore, the report provides information on undeclared enterprises; it is the prerogative of the Civil Service Bureau to review turnover.

ELGUJA GURGENIDZE

Deputy Chairman of Ambrolauri Sakrebulo

Elguja Gurgeniidze has not [declared](#) cooperative “[Mtis Balakhi](#)”, where he remains the chairperson of the board. He did not indicate in the declaration that he is registered as an [individual entrepreneur](#).



DAVIT GOGSADZE

Chairperson of the Property Management and Natural Resources Commission of Ambrolauri Sakrebulo

Davit Gogsadze has not [declared](#) cooperative “[Gabuni](#)” where to date he is a member of the board and director. This is a violation of the law.¹



TENGIZ GELOVNISHVILI

Chairperson of the Finance and Budget Commission of Ambrolauri Sakrebulo

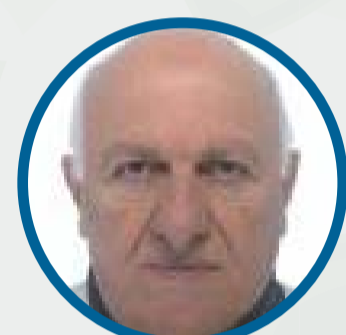
Tengiz Gelovnishvili has not indicated in his [declaration](#) that his wife, Shorena Gegeshidze, registered as an individual [entrepreneur](#) in 2017.



DAVIT KHUTSISHVILI

Chairperson of the Ambrolauri Sakrebulo faction “Georgian Dream - Democratic Georgia”

Davit Khutsishvili did not indicate cooperative “[Kheori](#)” in his [declaration](#), where he is the chairperson of the board. He also didn't indicate in his declaration that his father, Shago Khutsishvili, owns 100% of the shares and is the director of LLC “[Lukhuna](#)”.



GIVI KURTSIKIDZE

Chairperson of the Ambrolauri Sakrebulo faction “Ertoba”

Givi Kurtsikidze did not [declare](#) that he is the owner of 25% shares of LLC “[Gama Registri](#)”.



MAMUKA METONIDZE

Deputy Chairperson of the Ambrolauri Sakrebulo faction “Georgian Dream - Conservatives”

Mamuka Metonidze did not [declare](#) that his brother, [Vladimir Metonidze](#), and mother, [Darejan Metonidze](#), are registered as individual entrepreneurs.



GIORGI DONADZE

First Deputy Mayor of Ambrolauri

Giorgi Donadze did not [declare](#) that he owns 50% of the shares of LLC “[Mtsvane Samkaro](#)”. Moreover, he has not transferred management rights of his shares, which is a violation of the law.



NIKOLAZ KENCHADZE

Deputy Mayor of Ambrolauri

Nikoloz Kenchadze is registered as an individual [entrepreneur](#). This has not been indicated in his [declaration](#).



GIORGI GAGOSHIDZE

Head of Ambrolauri Sakrebulo Spatial Planning and Infrastructure Service

Giorgi Gagoshidze's wife, Tea Museridze, is the owner of a [building](#) in Ambrolauri, which was not indicated by Giorgi Gagoshidze in his [declaration](#).



MIKHEIL BOCHORISHVILI

Head of the Architectural Supervision Service of Ambrolauri Sakrebulo

According to the business registry, Mikheil Bochorishvili is registered as the director of LLC “[Avtotransregulireba Racha-Lechkhumi Kvemo Svaneti](#)”, which is not indicated in the [declaration](#). Moreover, he does not have the right to hold a position in a legal entity under private law.

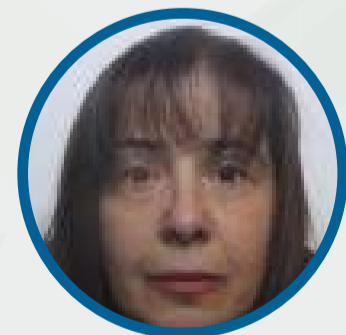


ALEKO KURTSIKIDZE

Head of the Architectural Supervision Service of Ambrolauri Sakrebulo

Aleko Kurtsikidze did not [declare](#) that he is an [individual entrepreneur](#).

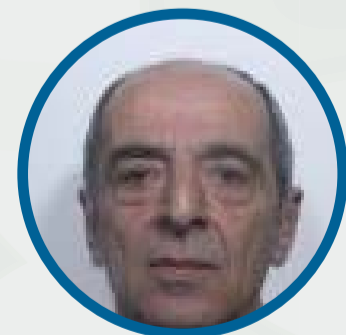

MANANA CHAGELISHVILI

Head of Education, Culture, Sports and Youth Affairs and Social and Health Services of Oni Sakrebulo

Manana Chagelishvili owns 35% of LLC “[Momavlis Profesiis Koleji](#)” which is not indicated in the asset [declaration](#). Chagelishvili has also not transferred management rights of her shares.



GIVI METREVELI

Chairperson of the Spatial-Territorial Planning and Infrastructure Commission of the Oni Sakrebulo

According to the business registry, Givi Metreveli is registered as an [individual entrepreneur](#). However, in spite of the requirements of the law, this information was not indicated in the [declaration](#).



VASIL METREVELI

Chairperson of the Oni Sakrebulo faction “Georgian Dream-Democratic Georgia”

Vasil Metreveli owns 25% of LLC “[Saba](#)”. This information has not been indicated in the [declaration](#). Furthermore, he has not transferred management rights of his shares.

Metreveli also owns 50% of LLC “[Terrako Georgia](#)”. In spite of the requirements of the law, he has not transferred management rights of his shares.

Transparency International Georgia calls on the Civil Service Bureau to act in accordance with the law in regard to the information provided in the report.
